## **International Citizens' Inquiry Into 9/11 to be Held in Toronto**

The International Citizens' Inquiry Into 9/11 will be held in Toronto May 25-30. This is Phase 2 of a series of such Inquiries, which launched in San Francisco in March. Phase 3 opens September 12, 2004 in New York City.

The Citizens' Inquiry brings together a broad coalition of people who question the US Government's version of the events of 9/11.

More and more people around the world are skeptical about what really happened on September 11, 2001.

- Why for nearly a two-hour period, did no jet interceptors turn a wheel until it was too late?
- Why did George W. Bush, after being told, "America is under attack," continue to listen for 20 minutes to a student talk about her pet goat?
- The twin towers were designed to withstand a plane crash. Why did they simply collapse in a free fall? And why was building 7 demolished? It was not damaged by the towers' destruction.
- What actually hit the Pentagon? The "hole" is too small for a large airliner and the expected debris was inexplicably absent.
- Why has the White House so strenuously resisted open public investigation into these events?

The Toronto Citizens' Inquiry will be the most ambitious such inquiry held in the world to date. It is anticipated that more than 1000 people will attend over the scheduled six-day event. The Inquiry will be held at the Ukrainian Cultural Centre and at Convocation Hall, University of Toronto.

9/11 widow Ellen Mariani, who is suing George W. Bush for the loss of her husband on September 11th, will address the Inquiry, as will her lawyer, Phil Berg. **John Gray, author of Men are from Mars, Women are from Venus will address the Inquiry on the subject "What Really Happened on 9/11 – The Need for Truth to Heal the 9/11 Families and America".**

Other leading 9/11 skeptics that will be speaking include:

- Michael C. Ruppert – former Los Angeles police detective;
- Thomas Kimmel – retired FBI Agent and US Navy officer;
- Michel Chossudovsky – author of War and Globalization, the Truth behind 9/11;
- Thierry Meyssan – author of 9/11 The Big Lie;
- Matthias Broeckers – best-selling German author/journalist – Conspiracy, Conspiracy Theories, and the Secrets of September 11

Other notable presenters are currently being confirmed.

The San Francisco Inquiry (Phase 1), held March 26-28, was attended by more than 1,500 people and was front-page news in California.
